## Convention 2005

The 14<sup>th</sup> Triennial Convention of the Union of Taxation Employees was held in Saint John New Brunswick from July 13 to 17<sup>th</sup> 2005. One hundred and forty seven delegates, one hundred and five observers and nine guests were in



attendance. A minute of silence was observed to commemorate the recent death of Sister Diana Gee, RVP for Greater Toronto. The Convention was dedicated to her memory.

The convention was four days of debate and discussion on issues that affect the running of the union for the next three years. Below are listed some of the topics covered:

- An operating budget for the years 2006, 2007 and 2008, which includes a dues increase of \$0.25 for each of the years, was approved.
- Delegates rejected a move to a percentage dues structure. UTE retains a flat rate structure.
- The 1st National Vice President became a full time paid position.
- The delegates voted an increase of one member per local for participation in the Equal Opportunities Conferences.
- A new standing committee was created: the Political Action Committee.
- The convention decided to hold one National and three Regional Health and Safety Conferences before the next convention. Funding will be provided for one member per workplace committee.
- UTE will hold a National EAP conference prior to the 2008 Triennial Convention with one delegate per local fully funded.

During Convention two members were recognized for their service.

Sister Joy Harrison, the First Vice President of the Southern Interior British Colombia Local, received the Godfroy Côté Award for her commitment to achieving the aims and objectives of the Union, and her exemplary service for thirty five years.



# MEMBERS SPEAK OUT

Union members often say that participating in a campaign such as mailing a postcard to their MP won't do anything. I say that one person **CAN** make a difference.

In May of 2005 the media reported that Agent Orange was sprayed at C.F.B. Gagetown, New Brunswick in 1966 and 1967. Documents obtained via the *Access To Information Act* show that there was spraying from 1956 to 1984. The DND and federal government will admit to spraying in 1966 and 1967.

The story was released approximately one week before my father's death. My father proudly served 26 years in the military attaining the rank of Master Warrant Officer. My father had a host of illnesses that I believe were linked to the defoliant sprayings. My 7 year old brother died in 1973 of Reyes Syndrome. My 27 year old pregnant sister died suddenly in 1983 of pulmonary embolism. Another sister suffered from endometriosis and a miscarriage. My mother was diagnosed with stomach cancer and through a procedure called a gastrectomy had her stomach removed in 1990. As I read the media stories I started connecting the dots.

My father died on May 24, 2005. I then started researching Agent Orange on the internet. There was a wealth of information so I created a website, <a href="www.agentorangealert.com">www.agentorangealert.com</a>, to share the information. I then emailed the media inviting them to visit the website. The phone began to ring.

I have been a guest on 5 radio "phone in" shows. I have been interviewed on CBC Radio as well as on CBC's The National. I have been interviewed by numerous newspapers. I was interviewed by an Emmy award winning journalist form the U.S. I have spoken with many politicians including meeting with Stephen Harper. Leader of the Progressive Conservative party to discuss the situation. The website has received over 275,000 "hits". I have received hundreds of emails with stories of illnesses and misery. I post these stories online. So many have said sharing and reading the stories have comforted them and helped make sense of it all.

So please the next time a union rep asks you to do something, **do it**. Please realize that small actions **can** make a difference. I never dreamed that my simple website would affect so many. I invite you all to make a difference!

# MEMBERS SPEAK OUT

#### Changes to the CRA

Have you ever stopped to consider the number of changes we have undergone since the Canada Revenue Agency was established? Here is an incomplete list of them, in no particular order, and I am sure you could add more:

- •Establishment of the Office of Dispute Management
- Self-service portal for employees
- NETFILE and TELEFILE for T2 filers
- NETFILE for T1 filers
- •NETFILE and TELEFILE for GST/HST filers
- •Establishment of national and regional pools for consolidating cases for the work
- Authentication management system
- Establishment of the MG group
- Establishment of 1-800 call centres
- Restructuring of the matching program
- •Tax payments made by clients using their debit cards
- Warehouse rationalization
- •End of regional compensation departments and establishment of two central offices
- Customs moves over to Service Canada and name changed from CCRA to CRA
- •Restructuring of the finance and administration division
- •Client access to My Account (address, production, change request and soon direct changes to their NETRAP tax return)
- •Bar codes on computer-generated tax returns
- Establishment of the ACS, elimination of the ACS and return of the ACS
- Closure of Cash/Counters

And finally, the announcement about the co-location of the support services of all Treasury Board organizations including agencies (we don't yet know what impact this could have on the CRA). You can see that there have been many changes to the CRA's activities. For some of them, we found out in time and were able to make changes. For others, we did not hear about them until after they were implemented.

The CRA's goal is to perform, therefore to do more with less. The outcome for us is determinate and/or indeterminate job cuts, employee displacements or non-renewals. The important thing to retain from all of this is that it isn't over. So if you know something, tell your union representative about it.

He/she may already be aware of it, but that's not important. Too much information is better than too little. Don't assume that your representative knows everything that goes on in your office. If you let your representative know, he/she will be able to question the appropriate person and obtain answers, and maybe even save your job.

#### The Rand Formula

Many members hear the word "rand" from time to time, many members hear the word to many times when it comes to strike votes or ratification votes. Have you ever been called a "rand" or hear someone else referred to as a "rand". Ever wonder where the word comes from or what it really means to be a "rand". The following is a brief explanation of why the word rand is used.

In 1945 workers at Ford Motor Company in Windsor, Ontario went on strike, the strike lasted 100 days and the main contention was that the union wanted a closed union shop, which means that you must be a union member before you can actually work in that shop. The federal government intervened and appointed Mr. Justice Ivan C. Rand, that might be a clue.

Justice Rand acted as a mediator hearing both sides of the argument then rendered a decision January 29, 1946. Justice Rands decision stated that all employees enjoy the fruits of collective bargaining and therefore must contribute to the union who bargained for them. The decision also required the employer to deduct the dues from the employees pay, known as "check-off" dues. Justice Rand however, also respected the rights of employees not wanting to join a union, for those who do not want to join the union they could choose to do so but they all had to pay the dues as they benefited as well. Therefore today a "rand" member is one who has not signed a union card but the union still collects the dues, as they enjoy the benefits gained. A "rand" member is not entitled to the same privileges as full members such as enjoying the right to attend meetings, seek elected office and even in some cases representation by the union. It's simple to go from a "rand" member to a full member, all you have to do is sign a union card. This "Rand Formula" spread far beyond Ford. It was later incorporated into labour law so that today it applies in almost all unionized workplaces, a distinctive feature of organized labour in Canada.
